TC: Expressed concern that employers are making applications in accordance with the minimum requirements of the standard, and some applicants consider recognition as another point in a resume, rather than the true role NDT level 3 should perform.		
MG: Board should consider what it wants Level 3 to be:		
- What is the minimum required technical attributes		
Experience (procedure development, examination writing etc.)		
Training		
Skill sets		
- What is the minimum acceptable requirements		
CH: The Board can write pre-requisites as it sees fit, including additional requirements above and beyond the standard.		ALL
FS: The standards are written to preserve the minimum requirements, and in writing the standard, the minimum requirement may be all that is required for an organisation.		
GJB: There should be a Level 3 applicant checklist. Evidence of procedure writing, examinations and training should be included. Garry was against any conditions/technical attributes that exceeded the minimum standard requirements.		
CH: Proposed the use of provisional L3 status and to provide NANDTB mentoring of the individual.		
NJ & SW: Support alignment with the current EN and NAS standard rather than a unique Australian standard.		
CH: proposed all board Members should formulate comments on NA-019 draft and return to him by 06/03/2015. Second SF. Approved.		
SF: Revise date to 13/03/2015 to align with responses to NA-013 (item 6.3). Approved all.
